# FoWB and NPS divorce

relationship of 25 years between Friends of the Wilderness Battlefield (FoWB) and the Fredericksburg Spotsylvania National Military Park has come to an end. FoWB President Bob Lookabill confirmed recently that the partnership agreement between the battlefield organization and the National Park Service has not been renewed. The agreement to staff and maintain historic Ellwood was originally forged 25 years ago.

"With the complete change in leadership at the Park over the last 12 months it was expected the agreement would finally be renewed. However, after many hours of negotiation and draft revision it was finally decided by both parties that FoWB has no real role at Ellwood Manor under current Interior Department policy," said Lookabill in a written statement. "It is obvious that volunteers do not currently fit in their plans. FoWB can no longer be in the house without a ranger present. The house will be open approximately half of the days this year

that it was open under FoWB supervision. The final straw came when the Park unilaterally decided to do away with tours of Ellwood, a job FoWB has done for 25 years."

Popular living history programs such as "Taming the Wilderness," that were hosted by FoWB will no longer be held on National Park Service property.

Meanwhile, FoWB has joined the Central Virginia Battlefield Trust in a suit against the Orange County Board of Supervisors regarding the proposed 2600-acre Wilderness Crossing development.

"We are not going away,"

reassures Lookabill. "FoWB has been in discussion with the American Battlefield Trust and the Central Battlefield Trust about maintaining, interpreting and enhancing some of their properties as we do for the State of Virginia. Additionally, we will look at presenting educational programs at these sites as we did in the past at Ellwood. We will also look to partnering with local educators in sponsoring programs as we have done previously. We will be here protecting and preserving your battlefields and property and educating future generations as we have done for over 25 years."

# The Charles Daniel Quisenberry Jewelry Store

This photo is believed to be the only surviving image of the interior of the Charles Daniel Quisenberry Jewelry Store in Orange. It was located on Main Street in the Rawlings Building/Sanford Block adjacent to the Orange National Bank.

The photograph dates to February 1907, confirmed by high resolution examination of the image where two editions of the Richmond Times Dispatch are visible in one of the display cases at the right of the image. From the visible advertisements and objects in the image, the Quisenberry store is known to have dealt in a variety of items including: pocket watches, fountain pens, silver service pieces, sewing machines, ornamental cane heads, shirt collar buttons, mantel clocks, silver decorative ornaments, and rambler bicycles, among other items. Quisenberry's labeled safe can be distinguished at the rear of the store as well.

In addition to many other civic roles, Quisenberry was president of the Orange chapter of the Anti-Saloon League. In 1933, Quisenberry moved his store across Main Street to the building formerly occupied by Grymes Drug Store.
